What is the overall <a href="#">deductible</a> ?	<b>\$200</b> /person or <b>\$600</b> /family for In- <a href="#">Network Providers</a> . <b>\$400</b> /person or <b>\$800</b> /family for Non- <a href="#">Network Providers</a> .	Generally, you must pay all of the costs from <a href="#">providers</a> up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. If you have other family members on the <a href="#">plan</a> , each family member must meet their own individual <a href="#">deductible</a> until the total amount of <a href="#">deductible</a> expenses paid by all family members meets the overall family <a href="#">deductible</a> .
Are there services covered before you meet your <a href="#">deductible</a> ?	Yes. <a href="#">Preventive Care</a> , Primary Care Visit, and <a href="#">Specialist</a> visit for In- <a href="#">Network Providers</a> . Dental, Tier 1a, Tier 1b, Tier 2, Tier 3 and Tier 4 <a href="#">Prescription Drugs</a> , and Vision for In- <a href="#">Network</a> and Non- <a href="#">Network providers</a> . The <a href="#">out-of-pocket limit</a> is the most you could pay in a year for covered services.
